HEARTH Act

- Interim Rule published by HUD July 31, 2012
- Goes into affect August 30, 2012
- Public Comment Due October 1, 2012
- Former SHP Grant now called the:
 - "Continuum of Care Program"
- The Interim Rule governs the 2012 CoC Grant Program



HEARTH Act

Continuum of Care (CoC) the group organized to carry out the responsibilities under the CoC Program and is composed of representatives of organizations including nonprofit homeless providers, victim service providers, faith based, government, business, public housing, schools, hospitals, law enforcement, veterans groups, etc, and homeless and formerly homeless, within a geographic area (Tarrant and Parker counties)



HEARTH Implementation for TX601

- Expands and codifies the role of a CoC to plan services and make application for funding to HUD
- Provides the mechanism to CoC Planning
 Funds Up to 3%, 2012 assumption 1-1.25%
- ESG programs very tied to a CoC Program (Arlington, Tarrant, Fort Worth)



HEARTH Implementation for TX601

- Requires the development of a Centralized/Coordinated Intake and Assessment System for the entire CoC
- Requires Performance Measurement and Monitoring of the CoC Program



The CoC Board

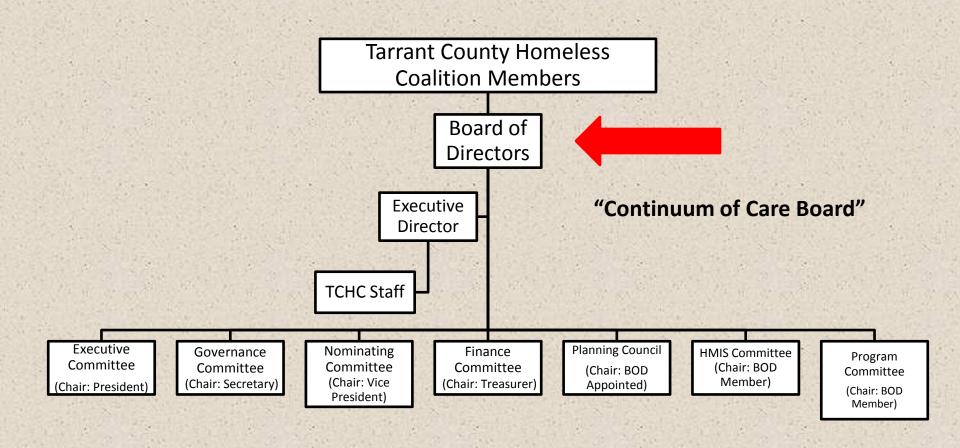
- Establish new CoC governance on how the CoC operates and documents how all groups, taskforces and committees created by the CoC Board support the CoC
- Have 2 years to do it (August 2014)
- Documentation of CoC submitted to HUD and through the CoC Program annual grant submission "Exhibit 1"



The CoC Board Responsibilities

- Operating the CoC (TCHC)
- Designate the HMIS (TCHC)
- CoC Planning (TCHC Board, TCHC Staff, Planning Council)







The New CoC Board Requirements

- CoC Board Meetings (at least semi annually)
- Annual call for members
- Written process to select Board
- Appoint committees as needed
- Follow charter detailing responsibilities
- Representative of geographic area, homeless, providers, sub populations, etc.



I. Operate the CoC

- Consult with recipients and subrecipients
- Establish performance targets
- Monitor performance
- Evaluate outcomes
- Take action against poor performers



I. Operate the CoC

- Evaluate and report to HUD outcomes of ESG and CoC projects
- Establish and operate a centralized / coordinated intake assessment system
- Establish written standards for providing CoC Assistance (CoC the grant)



II. Designate & Operate HMIS

- Designate a single HMIS (ETO)
- Select an eligible applicant to manage the CoC's HMIS (TCHC)
- Monitor recipient and sub participation (TCHC thru MOAs, HUD, TC, Arl, FW, DH grant agreements and ETO reports by TCHC)
- Review approve privacy security and data plans (HMIS Committee)



III. CoC Planning

- Coordinate the implementation of a housing and service system (Planning Council, TCHC Web Apps, TCHC training, HMIS, DH)
- Conduct PIT Count (Jan 2013 TCHC)
- Conduct Annual Gaps Analysis (TCHC Case Manager Assessment December, PIT Survey biennial)



III. CoC Planning

- Provide information to FW, Arl and Tarrant
 County on Consolidated Plan/CAPERs (TCHC)
- Consult with ESG regarding the allocation of ESG funds and the evaluation of the performance of ESG Recipients (FW, TC, Arl) and Subrecipients



CoC Board

- 1. Changes in governance and CoC Board Structure to:
 - Fully representative all interest groups
 - Provide 'arms length' separation from CoC Board oversight and the CoC Lead Agency CoC Operations and Planning activities, CoC Funding Application Decisions
 - Designate an eligible applicant to be the
 Collaborative Applicant who will be the recipient of the CoC Planning Dollars

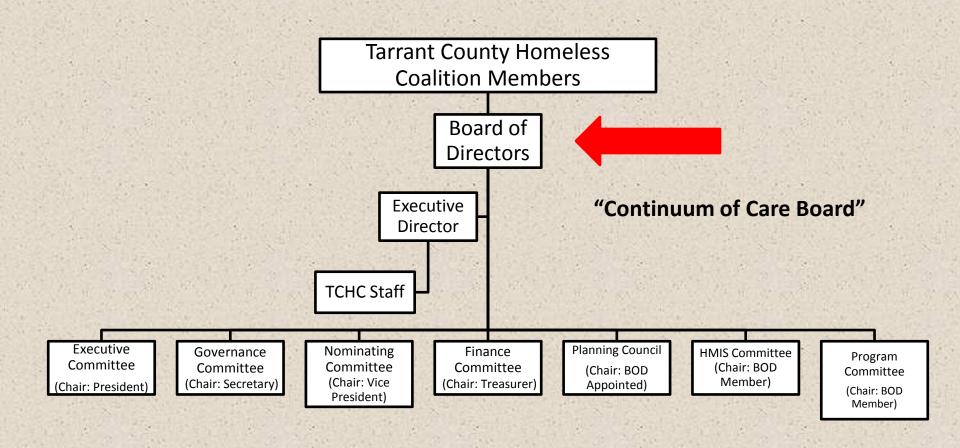


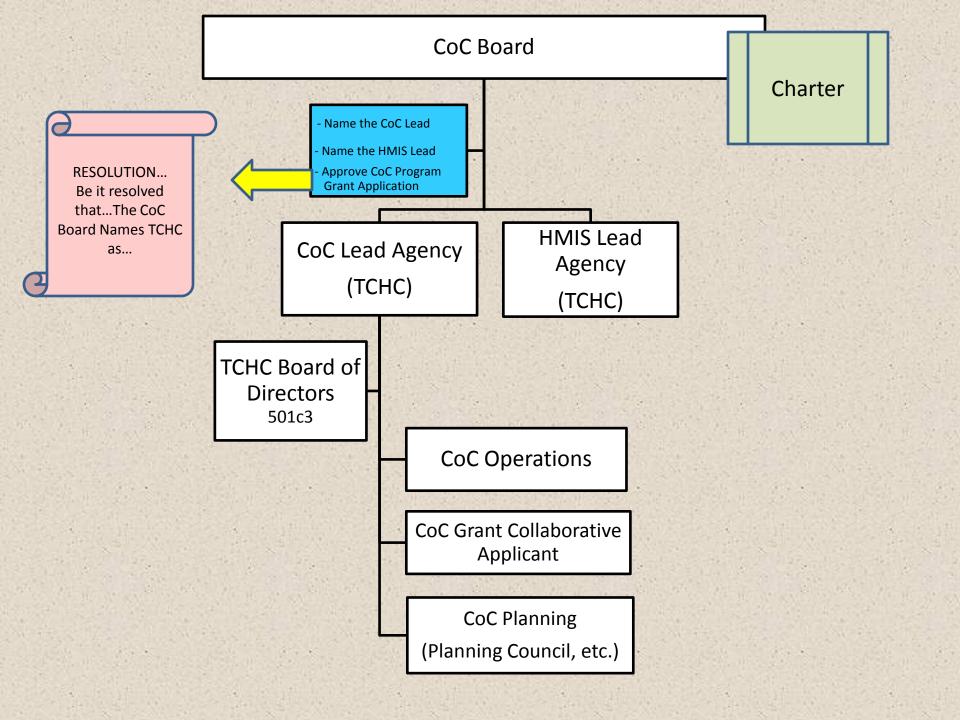
CoC Board

- Changes in governance and CoC Board Structure to:
 - Maintain TCHC as an eligible Collaborative
 Applicant as a 501 (c) 3 with its own Board, Bylaws with no conflict of interest issues

No one that receives CoC or ESG funds is an officer of TCHC









1. Change in Governance

TCHC Board Action: Executive Committee and Governance Committee form a task force to start the process of determining the governance of the CoC Board and the modification of the TCHC Board of Directors/Bylaws with the goal of implementation no later than September 2013.
